
Side View





FREQUENTLY ASKED

HOW BIG IS THE PHOTO BOOTH?

The inflatable setup is 4x3m and 2.4m in height, and the open air setup is 2.2sqm and 2.2m in height. For diagrams, please see pages 9-10.

WHAT ARE YOUR PAYMENT TERMS?

Before we send your invoice, you'll need to fill out our booking form. Once we recieve it, we'll send over your invoice. To secure the booking we require a £150 (non refundable) deposit, then the rest can be paid up to a week in advance if paying through bank transfer, or in cash on the day. If in the case of a last minute booking (within 7 days) we ask for full payment to ensure everything is ready for your special day. We do not accept cheques generally.

IS SETUP TIME OUTSIDE THE PACKAGE HOURS? HOW LONG DOES IT TAKE?

Yes setup time is definitely separate to your package hours so you will get the full time. Setup takes around 30-50mins and we'll arrive around 1hr 30 before the start time.

ARE YOU INSURED AND PAT TESTED?

We have public liability insurance that covers us up to 1 million and our equipment is PAT tested. If your venue asks for this documentaion, please send over this info pack as our documentation is at the bottom.

DO WE GET A DIGITAL COPY OF THE PICTURES TAKEN IN THE POD?

Yes! 100 per cent, we can give you a USB, or you can have them sent via email. We can also upload them to facebook or our website, making it super easy for guests to download them. We aim to get the images to you as soon as possible but please allow up to 7 days.

CAN WE HAVE COLOUR OR BLACK & WHITE PRINTS?

Your guests can choose to have coloured, black & white or the new feature on our system Sepia. It is quick and easy to change the settings on our touch screen interface. There is also the option of video messaging and an optional green screen for digital backgrounds.

WHAT CAMERAS AND LIGHTING DOES YOUR BOOTH USE?

Our booth uses high end professional DSLR 700 cameras resulting in sharp quality pictures. We also use photgraphy studio quality Elinchrom lighting and beauty dishes which bathes the subject in light meaning there are no light spots.

HOW DOES THE GUEST BOOK SERVICE WORK?

We print duplicate copies so there will be 1 for your guests and 1 for your guest book. We provide pens, scissors and glue and encourage your guests to leave messages next to their pictures. We will ensure the book is completed to a high standard and we hand deliver it to you at the end of your occasion in perfect order.

DO YOU STAY WITH THE PHOTO BOOTH?

A Fotoauto Operator will attend your event to take care of everything for you. When you hire an Fotoauto Photo Booth you can be sure that everything is in hand.

HOW MUCH DO YOU CHARGE FOR TRAVEL?

Travel is free within 50 miles of our base in Birmingham. A charge may need to be added to events outside of this radius.

WHAT ARE IDLE HOURS FOR?

Sometimes it is not always possible to set up or break down the photo booth safely and without restriction directly before or after an event. For example, if you require the booth setting up at 6pm but do not want it running until 9pm that is fine. However, this would be charged at 3 idle hours on top of the hire costs. Idle hours are charged at £25 per hour.

You need to also be aware that if we are prevented from breaking down at our time agreed, idle time will also have to be charged. So for example if we agree 6pm -10pm but your day doesn't finish 12.00am you will charged 2 hours idle time.

POWER REQUIREMENTS

We need connection to a standard 13Å plug socket within 25m to be able to work. We can and have done events in houses, boats, roof tops and marquees. No place is a silly place just ask.

WHAT IF WE BOOKED A PACKAGE THEN ON THE DAY NEED MORE TIME THAT WE DIDN'T CALCULATE FOR?

That is not a problem at all. If on the day you want more time and we don't have another booking behind yours we can stay on. You will need to give us at least an hours notice and we can take a cash or card payment for the excess time. The money will need to be payable on the hour.

CAN OUR GUESTS VIEW THE IMAGES AFTER THE EVENT?

Yes, we can upload the photos to our website or facebook for you. This makes it easy for your guests to download them, instead of coming to you to request the photos.

WHAT PRINTERS DO YOU USE?

Fotoauto uses thermal dye sublimation printers. These are the same as the top photo processing companies use and are the best and quickest in the business. The prints are fast, touch dry and water proof after 10 seconds.



Agreement to Online Terms and Conditions

When hiring a photo booth from us you do so in accordance with this hire agreement. You are deemed to have accepted the hire charge for the hire of the photo booth, and other terms such as delivery, which have been quoted to you at the time of placing your order.

Any contract for the hire of the photo booth is between you and Fotoauto.

These Terms and Conditions will remain in place on the website and can be accessed by you at any time. The Terms and Conditions displayed on the website at the time of booking your event shall apply to your booking. We reserve the right to amend or update our Terms and Conditions at any time and any subsequent bookings made by you shall be governed by such terms. We reserve the right to alter our pricing on our literature and website at any time without prior warning but this will not affect bookings which have been confirmed by us.

Private Bookings

Payment

If you wish to make a booking you must sign, date and return the quote to us no less than two full working days prior to the start of the hire period. All details stated on the booking form will be accepted by us as correct including spelling, punctuation and grammar, unless you notify us otherwise in writing. Any costs that we incur as a result of relying on incorrect information supplied by you must be reimbursed by you. In order to secure your booking a deposit of £150 must be paid. Once you email the booking form and the hire charge deposit we will notify you if your order has been accepted for the dates specified. A contract for the hire of the photo booth only comes into effect once we have confirmed your order.

The balance of the hire charge must be paid in advance of the hire term in accordance with the dates specified. You will be prompted via email to pay the balance by the due date. Failure to pay the balance by the due date will result in the cancellation of your order.

You are not entitled to a refund of any part of the hire charge where the hire period has ended early due to the photo booth being damaged, lost or stolen during the hire period or any breach by you of these Terms and Conditions.

Cancellation

In the event that you decide to cancel your booking you will lose the £150 deposit paid. You may give us more than 30 days' if you wish to cancel the booking and request that the deposit is transferred to an alternative booking. In such cases a cancellation fee will be charged. Basis of hire

Photo booths hired from us are not intended for your commercial use (apart from promotions) and must only be used in accordance with these Terms and Conditions.

The hire period for the photo booth is for the period specified on the booking form by you. This hire agreement is not covered by the Consumer Credit Act, 1974 as the hire period is less than 3 months. The hire period shall commence and end on the dates specified on the Booking Form. No extension to the Hire Period is permitted without our express written consent and receipt by us of the appropriate charge. If we are unable to install the photo booth on time due to access restrictions the hire period will remain unchanged. If your event simply starts late or runs late, the hire period will remain unchanged unless we agree to provide additional hours or to simply delay our planned start.

Installation and Use of the Photo Booth

Fotoauto will arrive two hours prior to an event to set up and test the photo booth correctly. If you require the photo booth to be set up in a shorter period then we cannot be held responsible if it is not setup correctly or ready on time. It is up to you to ensure that all appropriate consents and approvals have been obtained to ensure that Fotoauto are permitted access to install the photo booth at the requested location. Fotoauto cannot be held responsible for any of the above reasons we cannot deliver the Photo Booth on time for your event. You must ensure that the space provided for the photo booth is suitable for your request made. We have a variety of different size booths, so please ensure you provide these details at the time of booking and that you designated area will have an adequate power output.

The photo booths will be supervised by a member of the Fotoauto team that will be on site from the start of the event till termination. Our specialist team will be on hand in the event of any technical issues or other problems concerning the Photo Booth.

The social booth technology requires an internet connection for it's social media features, which shall be your responsibility to provide. The speed of connection will be dependent upon the service provider and we cannot be held liable for any delays in connection or connection failures as a result of using a 3G. If in the event the photo booths or any related equipment is damaged by a third party and you agree to indemnify us against loss, damage, cost or expense that we may incur as a result.

Risk and Ownership of the Photo Booth

Full ownership of the photo booth shall remain fully vested in us at all times. You have no right, title or interest in the photo booth other than that you are entitled to hire the photo booth for the hire period. You must maintain adequate insurance to cover the photo booth against fire, theft, loss or damage at all times during the hire period.

You hereby indemnify us against any losses, costs, damages or expenses that we may reasonably incur as a result of your breach of any of these Terms and Conditions and any loss or damage caused to the photo booth.

Termination of Hire

Fotoauto will not tolerate any abuse or threatening behaviour to any of our staff or abuse of the photo booth or equipment. If this occurs Fotoauto retain the right to terminate the hire immediately.

This applies equally to you and your guests. Fotoauto may terminate the hire in cases where our staff are of the reasonable view that the equipment including the photo booth itself belonging to Fotoauto is in danger of being damaged or has been damaged due to the actions or unruly behaviour of the people using the photo booth(s). We will tolerate unruly behavior to an extent and liaise with the venue first to try to resolve the matter before any termination is enacted. If we do terminate, for any reason, the full hire charge will remain due and we will not issue any refunds for any period of hire not provided.

We also reserve the right to terminate the Hire Agreement at any time if you are declared bankrupt, enter into any arrangement with your creditors, or being a company, go into liquidation or are wound-up, or being a partnership, is dissolved or if, in our reasonable opinion, one of the aforementioned events is likely to occur. We shall also be entitled to terminate the hire immediately where we have reasonable grounds to believe that you have acted in breach of this Hire Agreement

Privacy Policy

Data capture:

The photo booth may be set up to capture certain user data at the request of the hirer. Users will be notified of this at the time.

Facebook:

Fotoauto uses its own "Fotoauto" Facebook page to upload pictures along with a set message from our Photo Booths to Facebook.

Twitter:

Fotoauto uses its own "Fotoauto" Twitter account to upload pictures along with a set message from our Photo Booths to Twitter.

Email:

Fotoauto do not record or save any data of the users of this application unless stated.

Fotoauto do not record or save any data of the users of this application when users logon to their social media channels or emails

Limitation of Liability

We disclaim any and all liability to you for the supply of the photo booth to the fullest extent permissible under applicable law. This does not affect your statutory rights as a consumer. If we are found liable for any unforeseen cancellation, loss or damage to you, such liability is limited to the hire charge you have paid. We cannot accept any liability for any loss, damage or expense, including any direct or indirect loss such as loss of profits, to you howsoever arising.

We shall not be held liable for any failure or delay in performing the service and hiring the photo booth where such failure arises as a result of a Force Majeure event. In such circumstances our liability shall be limited to a pro rata refund of the deposit where applicable.

We do not accept liability for any indirect loss, consequential loss, loss of data, loss of income or profit, loss of damage to property and/or loss from claims of third parties arising out of the hire of the photo booth. We do not make any representation or guarantee that use of the photo booth in any promotional context will generate revenue or customers for you or your business.

We shall not be liable for any misrepresentations other than fraudulent misrepresentations.

Nothing in this Hire Agreement shall limit our liability for personal injury or death arising as a direct result of our negligence.

Fotoauto Staff

Staff supplied by Fotoauto for all types of events to set up, provide technical support and manage the photo booth for ease of use for your guest. As agreed with the Hirer prior to the start of the Hire Term, you must ensure that a minimum 30 minute break (taken at a mutually convenient point) is given to the operator for Hire Periods longer than 4 hours. Fotoauto staff should not be requested to undertake any additional function without first obtaining our consent.

General

We may subcontract any part or parts of the services that we provide to you from time to time and we may assign or novate any part or parts of our rights under these Terms and Conditions without your consent or any requirement to notify you.

We may alter or vary the Terms and Conditions at any time without notice to you.

The Hire Agreement constitutes the entire agreement between you and us. No other terms whether expressed or implied shall form part of this contract. In the event of any conflict between the Hire Agreement and any other term or provision, this Hire Agreement shall prevail.

If any term or condition of the Hire Agreement or these Terms and Conditions shall be deemed invalid, illegal or unenforceable, the parties hereby agree that such term or condition shall be deemed to be deleted and the remainder of the terms shall continue in force without such term or condition.

This Hire Agreement shall be governed by and construed in accordance with the laws of England and Wales. The parties hereto submit to the exclusive jurisdiction of the courts of England and Wales.

No delay or failure on our part to enforce our rights or remedies under the hire agreement shall constitute a waiver on our part of such rights or remedies unless such waiver is confirmed in writing.

It is not intended that the undertakings and obligations of the parties set out in this hire agreement shall be for the benefit of and capable of being enforced by any other person by virtue of the Contracts (Rights of Third Parties) Act 1999.

Mechanical Problems

On the rare occasion the Photo Booth may have technical problems every effort will be made to rectify the problem. If the problem is rectified the photo booth will made available for use over the time provided, if the problem is a printer problem photos will still be taken and photos will be printed out the next working day and sent to the client. No Refund shall be given unless the Photo booth cannot take photos from a camera failure or hard drive failure.
